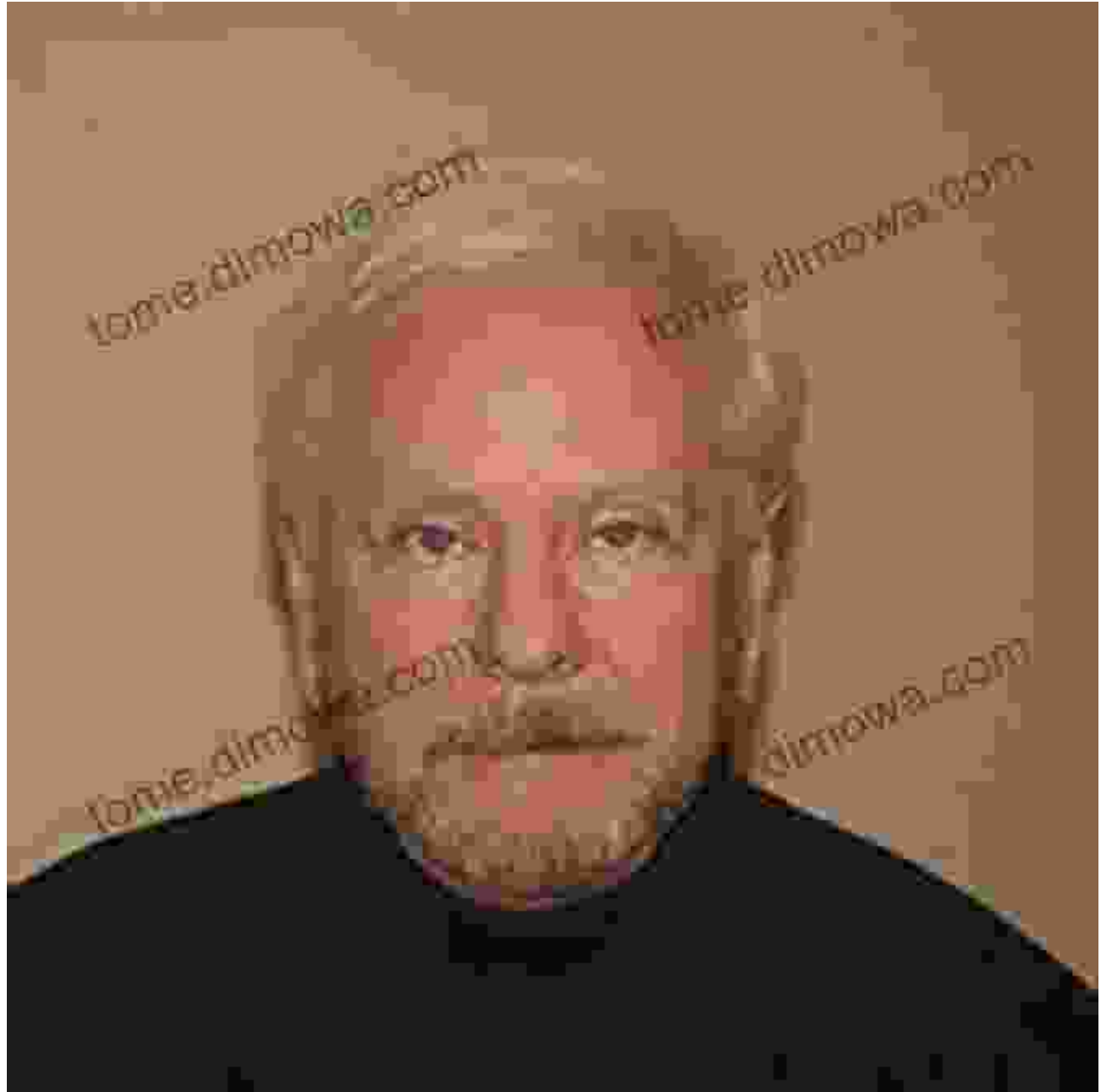


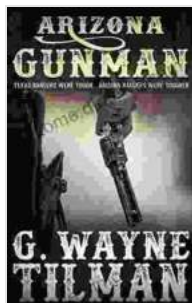
Arizona Gunman Wayne Tilman: A True Story of Vengeance and Justice

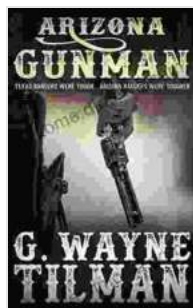
